

# Contributor Agreement

In order to protect your interests and those of the open flightmaps Association, a “Not for Profit” organization registered at Getreidegasse 32, in Salzburg, Austria, herein after referred to as OFMA, you agree that your contributions to the open flightmaps Database (OFMDb) are subject to the following conditions:

- 1.0 You confirm that you are a person over 18 years old and / or that you are a person of majority age in your country and that you act in good faith (in other words: you are neither representing nor acting on behalf of a company or other public or private legal entity, such as a university, etc.).
- 2.0 If you are employed and / or you have used the facilities of a company, or other public or private legal entity, to assist you in making your contribution to the OFMDb, you have obtained specific prior permission from your employer and / or the company or legal entity concerned to make your contribution and to accept these conditions.
- 3.0 As the data included in your contribution or on which your contribution is based upon may be subject to copyrights, you confirm that it complies with one or more of the following conditions:
  - 3.1 The data contributed by you is free from third party rights (because, e.g., it is in the public domain), or
  - 3.2 You made your contribution by deriving the data from one or more Aeronautical Information Publications (AIP) whose authors have agreed that the data may be included in the OFMDb (if the AIP was obtained by you from the EAD (European Aeronautical Information Service Database) website or from an OFMA website, it is automatically covered by a data user agreement between OFMA and Eurocontrol), or
  - 3.3 Your contribution is your own original work and you agree that it may be included in the OFMDb and used by others in accordance with the general user license agreement applied by OFMA.
- 4.0 You reserve all rights, title and interest in your contribution, but you hereby agree to grant OFMA a non-exclusive, perpetual, worldwide, no-charge, royalty free, irrevocable, sub-licensable and transferable license to reproduce, prepare derivative works of, publicly display and perform, make publicly available, broadcast, modify, translate and distribute your contributions and such derivative works.
- 5.0 OFMA agrees that it will make the OFMDb available to the general public without charge under a reasonable license agreement, including commercial use. Currently the license used requires all users who prepare derivative works based on the OFMDb to attribute OFM as a source of the data, and to report back to OFMA, or contribute, any modifications they, or any of their users, make to the data.
- 6.0 If you used a client application, program or other software provided by OFMA you acknowledge that this software is proprietary software subject to copyright, which may not be copied, distributed or otherwise exploited and may only be used personally by you.
- 7.0 This agreement is governed by the laws of the Republic of Austria excluding its conflict of laws rules and the United Nations Convention on Contracts for the International Sale of Goods. You irrevocably submit to the non-exclusive jurisdiction of the courts of Salzburg for the purpose of hearing and determining any dispute arising out of or in connection with this agreement
