

Legal and Copyright Notice

1. The open flightmaps Association (OFMA), of Getreidegasse 32, in Salzburg, Austria, is a “not for profit” organization set up to develop and maintain a comprehensive database of international aeronautical data, the Open Flight Maps Database (OFMDb), which can be used free of charge, in order to be able to assist the aeronautical community.
2. The OFMDb is a database which comes under the terms of Directive 96/9/EC of the European Parliament, and as such is subject to legal and copyright protection in all jurisdictions within the European Union, which inter alia means that it cannot be copied, in whole or in part, be translated, adapted, re-arranged or altered, and cannot be distributed or communicated, without prior permission from the OFMA, in its capacity as author of the database. In jurisdictions outside the European Union similar legal and copyright protection is provided by the World Intellectual Property Organization Copyright Treaty of 1996 (WIPO). In jurisdictions which are not members of the European Union or signatories of the WIPO Treaty, copyright infringements may be pursued under the legislation of the jurisdiction. This legal and copyright protection inter alia covers obtaining, verifying and presenting the contents of a database.
3. As it is the intention of the OFMA to provide access to the database as freely as possible, while complying with Directive 96/9/EC, and/or similar legislation, the OFMA requires all users to agree to a General Users’ License, which is explained in more detail in Item 8 below, but which grants the user a license to access the database for free in exchange for agreeing to certain conditions.
4. The individual pieces of data forming the contents of the database might not be covered by the copyright protection referred to in paragraph 2, but are subject to copyright protection as follows:
 - a. The copyright corresponding to original data provided by an OFMA contributor continues to be vested in the contributor. So

prior to submitting their contributions, all contributors must agree to the Contributor's Agreement allowing the OFMA to include their work in the database, and make it available to other users.

- b. A significant part of the aeronautical data has been based on, or derived from, Aeronautical Information Publications (AIPs), sourced periodically by national authorities and ceded to the European Aeronautical Information Service Database (EAD), in which case the data is covered by a general data user agreement entered into between the OFMA and the EAD, but the copyright continues to be vested in the provider of the data, normally the national authority.
 - c. Some data has been sourced from or derived from data in the public domain or data that is otherwise free from third party rights, and as a result is not subject to copyright. Consequently users can freely use both the data in the database and the information derived from it, provided they abide by the copyright terms specified in the OFMA General Users' License.
5. The servers used to host the database, the Web server, and the backups, are all privately owned and operated by sponsors of the OFMA. Consequently the OFMA retains the right to restrict access to some users, on a temporary or permanent basis, to be able to prevent abuses.
 6. The software used by contributors to input the data, to maintain the database, to display the information of the database to users, and to manage the Web server, has all been provided by private proprietary software developers as part of their sponsorship of the OFMA project, and its copyright continues to be vested in these different software providers. This is not "Open Source" software. The OFMA General Users' License does not grant any rights over any software.
 7. Several private software developers have developed specialized software to render the data contained in the OFMDb to present it in particular formats, compatible with specific applications, and in some cases incorporate other data, for instance basemap data sourced

from the Open Street Map project, under their user license; this rendering software is not covered by the OFMA General Users' License

8. In respect of users, OFMA makes the database available as freely as possible, to as wide a range of users as possible, but does so on two important conditions. Any user that copies the database, includes it in his/her application, or uses it to make a derivative database or a derived work, must:
 - a. clearly attribute the OFMA as a source of the data, and
 - b. if any changes, alterations, corrections or other modifications are made by the user to the data provided from the OFMDb, the user must contribute these changes within a reasonable timeframe that does not exceed 15 days calculated from the creation of the alteration(s) to the OFMDb, using one of the interfaces available, or
 - c. if unable to contribute the changes directly, the user must create a file, in one of the specified formats, including all the changes, and submit this file to the OFMA so that the changes can be input into the database, in a timely manner to be agreed (whereas the timeframe shall in any case not exceed 15 days calculated upon the creation of the alteration(s)) or
 - d. if the user has developed an application in which third party users give rise to changes, alterations, corrections or other modifications, the application must include a link, or some other interface, facilitating the contribution of the alterations of the data to the OFMDb by the users.
9. It should be emphasized that the intention of the OFMA is not to become the "owner" of the OFMDb, as the database must belong to the community of contributors that has made it possible. However in order to prevent legal conflicts arising out of ownership and copyright matters, the OFMA must clearly address these issues within the existing legal framework: consequently OFMA uses the Contributor's Agreement and the General Users' License in order to avoid potential legal problems. It is also necessary to control the quality and the accuracy of data and ensure that any updates are incorporated quickly. It is for this reason that the OFMA takes control of the OFMDb, in the interests of the community of contributors.

Unfortunately there are many examples of “open” projects based on databases that have been subject to abuse from unauthorized and/or uncontrolled contributors.
